Data Privacy Notice - Offering and Gift Aid

New Ground Churches

This Privacy Notice explains how we will collect, use, disclose and protect your personal data. The Notice applies to any person or organisation using a conference or event run by New Ground Churches (NGC).

NGC will process your personal data in accordance with the General Data Protection Regulations (GDPR).

What information do we collect from you?

We collect personal information from you, such as your contact and financial details.

How is your information collected?

We collect and store your information directly from you when you complete an offering and/or Gift Aid form.

How do we use your information?

We use your personal data for the administration of the offering and Gift Aid. We will share your information with volunteers outside of the NGC team where there is a justified operational need to do so. Your personal data are stored securely.

The legal basis that we use for processing your information is legitimate interest.

Who do we share your information with?

We do not and will not share or sell any of your personal information to anyone outside of NGC including third parties.

The company providing our Gift Aid software has access to your data, but we have a signed Data Sharing Agreement in place to protect your data.

How secure is your information and how long is it kept?

NGC has a robust Data Protection Policy in place to protect your information. All staff and volunteers have a responsibility to make sure that your data is handled securely. A copy of the Policy can be found on the website: newgroundchurches.org, this also includes our data retention schedule.

What are your rights?

You have the right to ask to see any information we hold about you by submitting a 'Subject Access Request' to the Data Protection Office at admin@newgroundchurches.org. You also have the right to ask for information, which you believe to be incorrect, to be rectified.
